TNO-B, Both Eyes

A series of Landoit Rings provides a precise measure of aculty with literates or illiterates. Used to determine visual acuity of 20/200 to 20/10 in 12 different levels.



TNO-L, Left Eye

This slide is similar in principle to that used for the Right Eye.



TNO-R, Right Eye

Same as Both Eyes except Landolt Ring symbols are omitted from left eye area. Permits measuring the habitual functioning of the Right Eye while both eyes look at the slide.
