2.) Does the governor have the authority to exercise line-item veto? - correct answer-Governors can exercise line-item vetoes. Line-item veto is removing specific lines from a budget

3.) Who has the power of executive clemency in the Georgia Constitution? - correct answer-Executive clemency (governor's pardon), The State Board of Pardons and Paroles

4.) What are the citizenship and residency requirements for Senate and House of GA and US? - correct answer-Georgia House of Representatives - must be 21 years old and must have residency in Georgia for at least 2 years and for at least 1 year in the district that he or she represents and resides

US House - must be 25 years old, a citizen of the US for at least 7 years prior to the election, a resident of the state that he or she has chosen to represent

Georgia Senate - must be 25 years old and must have residency in Georgia for at least 2 years and for at least 1 year in the district that he or she represents

US Senate - must be 30 years old, a citizen of the US for at least 9 years prior to election , a resident of the state represented

5.) What are the responsibilities of the lieutenant governor in Georgia? - correct answer-Lieutenant governor aka president of the senate oversees committee on senate membership. They do not run with governor, elected separately.
