- Don't let sterile package get damp/wet
- Always face a sterile field.
- Hold all sterile items above waist level
- Place sterile items in the middle of sterile field.
- Don't spill liquid onto sterile field
- Don't cough/sneeze/talk over sterile field
- Never reach over sterile field.
- Don't pass soiled items over sterile field.
- Notify provider of contamination!

3. WOUND CHARACTERISTICS

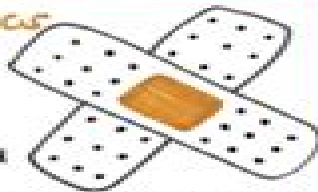

- **ECRU**: clear
- **SANGUINEOUS**: blood-tinged
- **ECCHYMOSIS**: pinkish, or clear & red mix
- **PURULENT**: white, green, or yellow-tinged usually accompanied by unpleasant odor
↳ INFECTION!

— AMOUNT —

- **COPIOUS**: large amount
- **MEDIUM**: moderate amount
- **SCANT**: small amount

↑ **DEBRIDEMENT**: separation or opening of the edges of a wound.



2. WHAT DO CDC & OSHA MANDATE?

- **CENTER FOR DISEASE CONTROL & PREVENTION (CDC)**: US public health agency in charge of tracking & investigating disease trends/outbreaks
↳ aim to protect PT AND WORKERS
- **OCCUPATIONAL SAFETY & HEALTH ADMINISTRATION (OSHA)**: protect the health & safety of workers
↳ mandate safe environment free of hazards for employee.

4. ANAPHYLACTIC RXN

- **ANAPHYLAXIS**: severe allergic rxn
- Allergic rxn is generalized rxn that can occur within minutes to hrs after exposure to **ALLERGEN** (substance that immune system recognizes as foreign)
- **PRIMARY RULE**: the sooner the symptoms, the more severe the rxn will be!
- Initial v/v:
 - severe itching
 - feeling of warmth
 - Tightness in throat or chest
 - Rash
