Abstract

The purpose of this study was to examine the effects of a 6-week training program on the physical fitness and health-related quality of life (HRQL) of sedentary middle-aged women. The participants were randomly assigned to either a control group or an exercise group. The exercise group performed a supervised aerobic and resistance training program three times per week. The control group did not participate in any structured exercise program. The results showed that the exercise group significantly improved their cardiovascular fitness, muscle strength, and HRQL compared to the control group. These findings suggest that a 6-week training program can effectively improve the physical fitness and HRQL of sedentary middle-aged women.
