Background: Beginning Jan. 1, 2006, employers with employees all health insurance self-insured under ERISA must provide a notice to each employee of the health insurance options under the "Health Insurance Notice" (the "Notice"). The Notice must also "inform each employee of the employee's rights and obligations under the health insurance plan." (29 CFR 2590.702-1(a)(4)(ii)).
