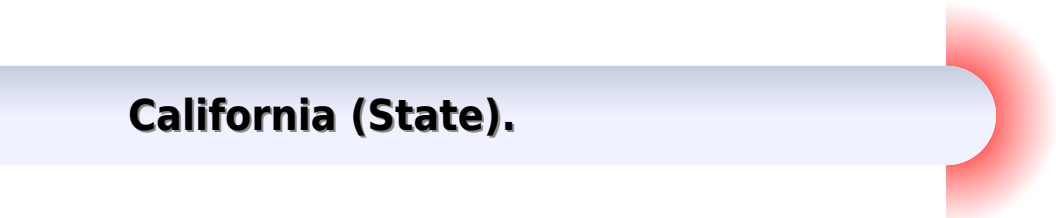
But I'm going to try them for robbery, and I promise you that. And you're going to convict them, and acquit him....
