book Nie considers the factors that make some public land conflicts so controversial revisits how they have been dealt with in the past and proposes ways they might be better managed in the future Eschewing the single policy approach to public lands management such as encouraging free markets he instead surveys a diverse array of other available options His big picture outlook for the twenty first century is a bold call for reshaping ongoing conflicts and for reinvesting in our public lands
