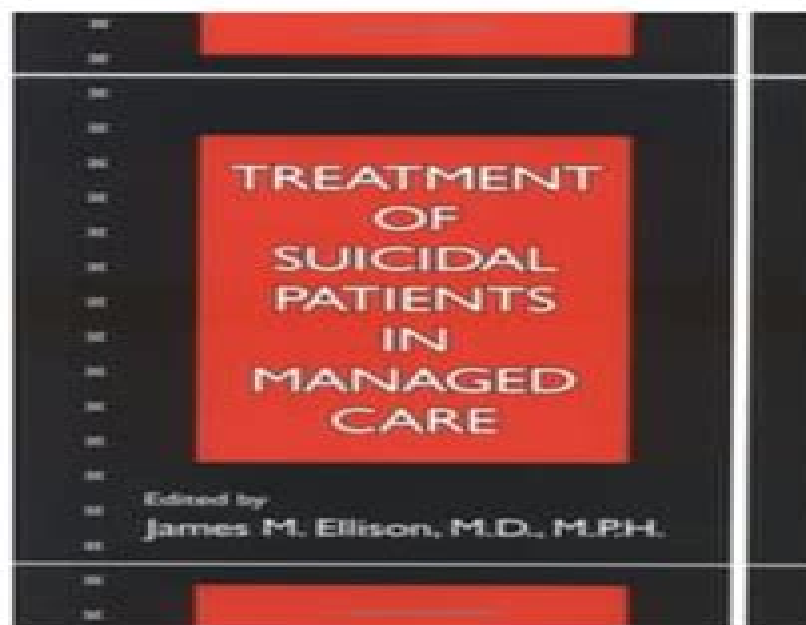

Suicide risk among adolescents and the elderly For adolescents emphasizes the value of multiple levels of care when admissions are too short and too often followed by distressing and costly readmissions. For the elderly offers preventive interventions for primary care physicians who are uncomfortable discussing depression and suicidal ideation and intention with their elderly patients. Suicide and substance abuse Details the role of case managers in providing continuity of care in a disorder known to be chronic and relapsing.
