EMPLOYEE RIGHTS UNDER THE FAMILY AND MEDICAL LEAVE ACT

What is FMLA? The Family and Medical Leave Act (FMLA) gives eligible employees the right to take unpaid, job-protected leave for certain family and medical reasons. FMLA leave is unpaid, but your employer must maintain your health insurance coverage during the leave.

Who is eligible? You are eligible for FMLA if you have worked for a covered employer for at least 12 months and at least 1,250 hours in the 12 months before the leave begins.

What are the reasons for FMLA leave? FMLA leave is available for the following reasons:

- The birth, adoption, or placement of a child.
- The care of a child, spouse, or parent with a serious health condition.
- Your own serious health condition that makes you unable to perform your job.
- A military caregiver's need to care for a covered service member with a serious health condition.

How much leave can I take? Most employees are entitled to 12 weeks of FMLA leave in a 12-month period. Some employees may be eligible for more leave.

What are my employer's obligations? Your employer must maintain your health insurance coverage during the leave. They must also restore you to your original or an equivalent position upon your return.

What are my obligations? You must give your employer advance notice of your leave and provide medical certification of the need for leave.

What if my employer violates FMLA? If your employer violates FMLA, you may be entitled to remedies such as reinstatement, back pay, and damages.

YOUR RIGHTS UNDER USERRA THE UNEMPLOYED SERVICE EMPLOYMENT AND REEMPLOYMENT RIGHTS ACT

What is USERRA? The Uniformed Services Uniformed Services Employment and Reemployment Rights Act (USERRA) protects the rights of service members and veterans to return to their civilian jobs after military service.

Who is eligible? You are eligible for USERRA if you are a member of the uniformed services of the United States and have been discharged from service.

What are the rights under USERRA? USERRA guarantees the right to return to a job after military service. It also prohibits discrimination against service members and veterans in hiring, promotion, and other employment practices.

What are my employer's obligations? Your employer must restore you to your original or an equivalent position upon your return. They must also provide you with the same benefits and seniority as if you had not been in the military.

What are my obligations? You must give your employer advance notice of your return and provide medical certification of your service.

What if my employer violates USERRA? If your employer violates USERRA, you may be entitled to remedies such as reinstatement, back pay, and damages.

Job Safety and Health IT'S THE LAW!

- All workers have the right to:**
- A safe workplace.
 - Receive a copy of a health statement with your employer or OSHA, or report a work-related injury or illness, without being retaliated against.
 - Receive information and training on job hazards, including all hazardous substances in your workplace.
 - Request a confidential OSHA inspection of your workplace if you believe there are unsafe or unhealthy conditions. You have the right to have a representative contact OSHA on your behalf.
 - Participate (or have your representative participate) in an OSHA inspection and review in advance to the inspection.
 - File a complaint with OSHA within 30 days of the violation, online or by mail if you have been retaliated against for using your rights.
 - See any OSHA citations issued to your employer.
 - Request copies of your medical records, tests that measure hazards in the workplace, and the workplace injury and illness log.
- Employers must:**
- Provide employees a workplace free from recognized hazards. It is illegal to retaliate against an employee for using any of these rights under the law, including filing a health and safety complaint with you or with OSHA, or reporting a work-related injury or illness.
 - Comply with all applicable OSHA standards.
 - Notify OSHA within 8 hours of a workplace fatality or within 24 hours of any work-related employee hospitalization, amputation, or loss of an eye.
 - Provide required training to all workers in a language and vocabulary they can understand.
 - Prominently display this poster in the workplace.
 - Post OSHA citations at or near the place of the alleged violations.
- On-Site Consultation services are available to small and medium-sized employers, without cost or penalty, through OSHA-supported consultation programs in every state.**

EMPLOYEE RIGHTS UNDER THE FAIR LABOR STANDARDS ACT

FEDERAL MINIMUM WAGE \$7.25

What is the FLSA? The Fair Labor Standards Act (FLSA) sets the federal minimum wage, overtime pay, and child labor standards.

Who is eligible? Most employees are covered by the FLSA. Some employees, such as those in agriculture, stock raising, and fishing, are exempt.

What are the rights under the FLSA? The FLSA guarantees the right to a minimum wage of at least \$7.25 per hour. It also guarantees the right to overtime pay of at least 1.5 times the regular rate for hours worked in excess of 40 hours per week.

What are my employer's obligations? Your employer must pay you at least the minimum wage and overtime pay. They must also keep accurate records of your hours worked and wages paid.

What are my obligations? You must keep accurate records of your hours worked and wages paid.

What if my employer violates the FLSA? If your employer violates the FLSA, you may be entitled to remedies such as back pay, damages, and civil penalties.

EMPLOYEE RIGHTS EMPLOYEE POLYGRAPH PROTECTION ACT

What is the EPPA? The Employee Polygraph Protection Act (EPPA) prohibits employers from using lie detector tests to screen or monitor employees.

Who is eligible? Most employees are covered by the EPPA. Some employees, such as those in security, law enforcement, and the transportation industry, are exempt.

What are the rights under the EPPA? The EPPA prohibits employers from using lie detector tests to screen or monitor employees. It also prohibits employers from asking employees to take a lie detector test.

What are my employer's obligations? Your employer must not use lie detector tests to screen or monitor employees. They must also not ask you to take a lie detector test.

What are my obligations? You must not take a lie detector test if your employer asks you to.

What if my employer violates the EPPA? If your employer violates the EPPA, you may be entitled to remedies such as reinstatement, back pay, and damages.

Equal Employment Opportunity in THE LAW

What is EEO? The Equal Employment Opportunity Act (EEO) prohibits employers from discriminating against employees on the basis of race, sex, age, and other characteristics.

Who is eligible? Most employees are covered by the EEO. Some employees, such as those in the military and government, are exempt.

What are the rights under the EEO? The EEO prohibits employers from discriminating against employees on the basis of race, sex, age, and other characteristics. It also prohibits employers from asking employees to take a test that is discriminatory.

What are my employer's obligations? Your employer must not discriminate against employees on the basis of race, sex, age, and other characteristics. They must also not ask you to take a discriminatory test.

What are my obligations? You must not take a discriminatory test if your employer asks you to.

What if my employer violates the EEO? If your employer violates the EEO, you may be entitled to remedies such as reinstatement, back pay, and damages.

Paycheck Checkup Can Prevent a Tax-Time Surprise

What is a Paycheck Checkup? A Paycheck Checkup is a free service that helps employees verify that their paychecks are correct and that their employers are complying with the law.

Who is eligible? All employees are eligible for a Paycheck Checkup.

What are the benefits of a Paycheck Checkup? A Paycheck Checkup can help employees identify and resolve pay problems before they become a tax-time surprise. It can also help employees understand their rights under the law.

How to get a Paycheck Checkup? Employees can get a Paycheck Checkup by visiting the website www.dol.gov/eisv or by calling 1-800-321-OSHA.

2022 minimum wage: \$14.45 per hour

Washington's minimum wage will be \$14.45 per hour starting Jan. 1, 2022. Minimum wage will rise to \$15.00 per hour for paid 90% of the cost minimum wage, at \$15.00 per hour.



Domestic Violence Leave

What is Domestic Violence Leave? Domestic Violence Leave is a type of leave that allows employees to take time off work to deal with domestic violence.

Who is eligible? Employees who are victims of domestic violence are eligible for Domestic Violence Leave.

What are the rights under Domestic Violence Leave? Employees who are victims of domestic violence are entitled to take up to 5 business days of leave per year for Domestic Violence Leave.

What are my employer's obligations? Your employer must allow you to take Domestic Violence Leave. They must also not retaliate against you for taking Domestic Violence Leave.

What are my obligations? You must provide your employer with a certification from a law enforcement agency or a healthcare provider that you are a victim of domestic violence.

What if my employer violates Domestic Violence Leave? If your employer violates Domestic Violence Leave, you may be entitled to remedies such as reinstatement, back pay, and damages.

Who is eligible? All employers are eligible for the Notice to Employees.

What are my employer's obligations? Your employer must post the Notice to Employees in your workplace. They must also not retaliate against you for filing a complaint with OSHA.

What are my obligations? You must not file a false complaint with OSHA.

What if my employer violates the Notice to Employees? If your employer violates the Notice to Employees, you may be entitled to remedies such as reinstatement, back pay, and damages.

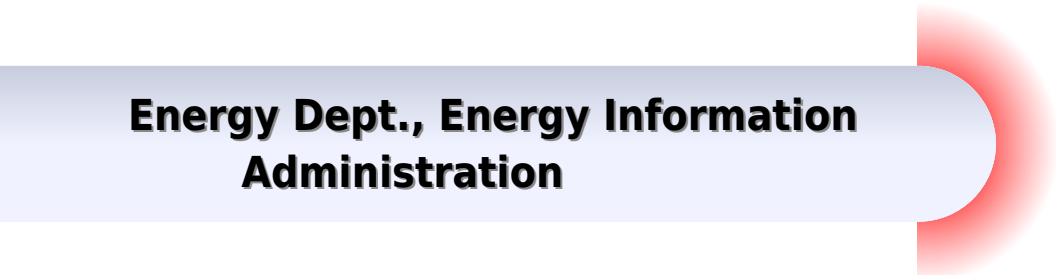
