Some localities have issued draft regulations for public input, and the State Council for the first time experimented with a kind of "notice and comment" procedure characteristic of United States administrative rule making when it published the draft of national property-management regulations in two newspapers of national circulation, as well as on the website of some local governments. The State Council received nearly 350 comments that were taken into account before finalizing the June 2003 regulations. What we are seeing is in fact progress, endorsed in general terms by the party, toward resolving many of the systemic rule-of-law weakness enumerated by Peerenboom. Experiments with greater public input, more outspoken media, greater access to government-held information, and more independent and robust business associations and consumer rights, environmental, and other interest groups are all taking place. Work continues in important areas such as a comprehensive Administrative Procedure Act to standardize and restrain bureaucratic behavior, a restructuring of the courts to achieve greater independence from government in terms of funding and appointment, and efforts to promote a rule-of-law culture.
