Labour Court:

 If disputes are unresolved, a referral to the Labour Court can be made for adjudication under Section 77 of the LRA, especially for unfair labour practices.

Picketing and Strikes:

 Unions may apply for picketing rights if unilateral changes occur, but compliance with valid picketing rules is mandatory to avoid misconduct.
