

# COI - Personal Relationships with Suppliers

- Walmart makes relationships with suppliers on efficient, fair and lawful business practices. - When a former Walmart officer takes a position with, or on behalf of, a supplier, Walmart will not do business with that officer for one (1) year following separation, regardless of the area in which the former officer was involved
- Walmart encourages associates not to have social or other relationships with suppliers that a business influence is being exerted.
