



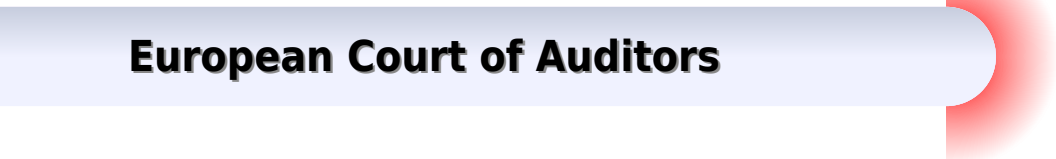

For each of these issues, the authors analyse to what extent national legislators have been ready to adapt their national systems in order to fulfill the aims of the EU directives. They also identify unintended or at least not explicit effects of the implementation process. The authors clearly reveal whether the ambitions of the EU when initiating this process can be detected in the implementation process and how implementation of the three directives have changed and could change national law on these issues.
