I believe, though, that the process and planning tips are generic enough to apply to the other print documents, in accordance with both their purpose and scope (mospagebreak title=Step By Step). The quality (ability to communicate) of the support documentation directly affects the level of after-sales support required. Since technical writers are trained in the black art of communication, it usually makes more sense to hire one for the support documentation needed, rather than have a developer do it.

Documentation, as a process, begins (ideally!) right at the point where the development team has finalized the software design, because:

- That provides enough fodder for you, the writer, to start planning the structure of the manual.
- You have a better chance of understanding the software if you ask
