

policies that impoverish people and their environment Walking the Talk explores the opportunities and challenges inherent in eco efficiency producing more with less corporate social responsibility and a transparent wired world where reputations can be irreversibly damaged or enhanced in real time It also devotes a chapter to ways in which corporations can and must learn to change It examines the new partnerships needed among companies governments and civil society to produce real change and the ways in which these alliances can work for all concerned And it argues that consumer choice and consumer information should be encouraged as a positive force for sustainable development Only what is valued is carefully used and so creating markets for environmental goods and services may be the best way to protect scarce resources.
