unfunded party from unjust results 1 the identity of the funder shall be disclosed but the content of the funding agreement will be disclosed only if normal evidentiary burden has been fulfilled 2 arbitral tribunals should consider all relevant circumstances of the case when considering applications for security for costs and it should be made clear that mere existence of funding relationship does not lead to an automatic order for security for costs 3 amending the Arbitration Ordinance is the most direct way to make funders liable for adverse costs orders but the statute should be amended in such a way that the non signatories law is respected funders are not punished and opponents are not getting a windfall
