The outsourcing of military and security services, previously a paradigmatic governmental function, to private commercial entities in the form of Private Military and Security Companies (PMSCs) is a contemporary phenomenon that has gained momentum in the course of the past decade. The growth of the PMSC industry not only outstripped the military presence on the ground in Afghanistan and Iraq towards the end of those operations, but outpaced attempts at formulating coherent law and policy. Indeed, basic characteristics of the PMSC industry such as its size and level of involvement are hazy, and the categorisation of its constituent companies remains contentious. The range of challenges that this industry presents in the legal sphere alone is supplemented by the additional layers of complexity created by PMSCs which are such that, despite War by Contract being published some eight years after the initial military operations in Afghanistan and Iraq, our understandings of these developments have not significantly advanced. Thus, War by Contract is simultaneously a monumental academic achievement addressing an impressive array of issues incisively, while also appearing to only skim the tip of the iceberg of the PMSC industry. This effect is exacerbated by the difficulties inherent in the subject-matter, which, when coupled with necessary space constraints, frustratingly result at times in an apparently cursory manner being adopted in some chapters in which important implications arising from the arguments presented are superficially addressed.

The corresponding academic interest in the development and evolution of the PMSC industry has spawned a significant number of publications addressing the issue from a range of disciplinary perspectives. The vast majority of current academic consideration of PMSCs views the industry as a fait accompli, and thus coalesces around refining the relationship between the industry and the military or focuses on analysing the repercussions associated with governance and security of the privatised provision of military services and security. Thus, War by Contract stands out by virtue of its focus upon the regulatory and governance roles played by international human rights law and international humanitarian law, which are further supplemented by criminal and civil
