War Crimes Trials and Other Essays Carlos Whitlock Porter, 2018-10 Approximately 10 000 War Crimes Trials have been held since 1945 Trials of Japanese military personnel ended in 1949 yet war crimes trials of Germans and Eastern Europeans continue to date Almost invariably the charge is violation of the laws and customs of war derived in turn from international conventions signed at the Hague in 1899 and 1907 That these trials have little or no basis in law is clear from the wording of the treaties which are said to have been violated The illegalities of war crimes proceedings include the admissibility of oral and written hearsay the introduction of the concept of conspiracy into international law unknown prior to 1945 the total lack of any pre trial inquest or forensic evidence and trial before a court itself composed of actual war criminals To quote the writings of Telford Taylor The issues surrounding the war crimes trials are numerous and complex discussion and criticism of what was done should be welcomed by all who hope for a continuing development of international law but what should have been done instead is a problem generally ignored by those who condemn what was done in fact 99 The alternative is a fair trial before an impartial court under existing procedures and proper rules of evidence

confiscated wartime records to Japan before microfilming them making it impossible to determine the extent of Japan's guilt. Others were convinced that the U.S. government retained highly classified documents that would prove Japanese guilt beyond doubt and implicate the highest levels of Japanese government and society in the crimes. These issues led concerned parties to investigate Japanese wartime records among the holdings at the U.S. National Archives and Records Administration (NARA) in College Park, Maryland, and at other U.S. government agencies. Thorough documentation of Japanese war crimes and criminal activities among these holdings seemed unavailable, leading to speculation of an official cover-up. Suspicions that the U.S. government was deliberately concealing dark secrets were fueled when, instead of finding the records they sought, researchers encountered a card stating the records had been withdrawn for security reasons, as well as when they received a notice that requested information could not be located.

The Dismantling of Japan's Empire in East Asia Barak Kushner, Sherzod Muminov, 2016-12-08

The end of Japan's empire appeared to happen very suddenly and cleanly, but as this book shows, it was in fact very messy, with a long period of establishing or re-establishing the postwar order. Moreover, as the authors argue, empires have afterlives, which in the case of Japan's empire is not much studied. This book considers the details of deimperialization, including the repatriation of Japanese personnel, the redrawing of boundaries, issues to do with prisoners of war and war criminals, and new arrangements for democratic political institutions, for media, and for the regulation of trade.
