Additionally, a new simple tool for measuring the resilience of financial institutions to these systemic shocks is provided. We examine the characteristics and stability of systemic risk and uncertainty in relation to the dynamics of the banking sector stock returns. This sort of evidence is supportive of past claims made in the field of macroeconomics which hold that during the global financial crisis the financial system may have faced stronger versions of traditional shocks rather than a new type of shock. In chapter 5, Currency downside risk, liquidity and financial stability, downside risk propagation across global currency markets and the ways in which it is related to liquidity is analyzed. Two primary contributions to the literature follow. First, tail spillovers between currencies in the global FX market are estimated. This index is easy to build and does not require intraday data, which constitutes an important advantage. Second, we show that turnover is related to risk spillovers in global currency markets. Chapter 6 is entitled, Spillovers from the United States to Latin American and G7 Stock Markets: A VAR Quantile Analysis. This chapter contributes to the studies of contagion, market integration and cross border spillovers during both regular and crisis episodes by carrying out a multivariate quantile analysis. It focuses on Latin American stock markets which have been characterized by a highly positive dynamic in recent decades in terms of market capitalization and liquidity ratios after a far reaching process of market liberalization and reforms to pension funds across the continent during the 80s and 90s. We document smaller dependences between the LA markets and the US market than those between the US and the developed economies, especially in the highest and lowest quantiles.
