"Germany accepts the responsibility of Germany and her allies for causing all the loss and damage to which the Allied and Associated Governments and their nationals have been subjected as a consequence of the war imposed upon them by the aggression of Germany and her allies."

"The German armed forces must not exceed 100,000 men, including officers.

Conscription is abolished in Germany. The manufacture, import, and export of arms, munitions, and war material are strictly forbidden. Germany shall not maintain or construct any fortifications in the Rhineland."
