institutions like UNESCO GEF UNEP and at the European Commission have both an extended expertise on how to bridge the gap between science and political decision making which is the main factor for an effective governance of water resources. What is new in the book is the integrated analysis of transboundary governance of both surface water and groundwater as it occurs in reality. In current literature groundwater is still often missing for the benefit of surface water or on the contrary it is treated separately from surface water.
