Many women writers even when they did not publicly advocate economic independence for women supported themselves and their families throughout their writing careers and in their fiction portrayed the importance of money in women's lives. Together the evidence of the court cases and the writers runs counter to the official narrative which scripted women as economically dependent and financially uninvolved.
