Une victoire face aux multinationales Anne Le Strat, 2015-09-10 Comment une jeune femme de plus de 30 ans se retrouve-t-elle lutter contre des multinationales de puissants lobbys et bon nombre de politiques ? C'est ce que nous raconte ici la jeune femme en question Anne Le Strat, principale actrice de la remunicipalisation de l'eau à Paris. Lorsque le Conseil de Paris décide de remunicipaliser l'eau de la capitale en 2008, la gestion de cette ressource est assurée par les groupes Veolia et Suez. Un système de délégation au privé vieux de 25 ans, souvent critiqué pour son coût mais surtout pour son opacité financière et l'absence de maîtrise par la collectivité. Cette décision est l'aboutissement d'une bataille politique entamée lors du premier mandat de Bertrand Delanoë, PS, à la mairie de Paris 2001-2008. Anne Le Strat est alors une nouvelle luecologue. Ayant quitté ses fonctions d'adjointe au maire en avril 2014, elle revient ici pour la première fois les coulisses de cette bataille. Au fil de son récit, elle détaille les différents jeux d'influence ouverts ou souterrains des protagonistes : les entreprises, les politiques, les médias, la technostructure. Au-delà du cas de l'eau parisienne, elle propose une passionnante réflexion sur les conditions de réalisation d'une réforme au nom du bien commun. Faire de la politique aujourd'hui, confronter ses idées au réel, mettre en œuvre ses convictions, est encore possible, telle est la morale qui se dégage de cette aventure.
