# Unilateral Changes to Terms & Conditions of Employment (Section 64 LRA)

#### Common Law:

- · Contract of employment is governed by common law principles, which require a valid contract.
- Labour legislation supplements these principles to ensure fairness.

#### Labour Legislation:

- · Labour Relations Act: Requires fair labour practices throughout employment.
- Basic Conditions of Employment Act: Sets minimum employment conditions.
- National Minimum Wage Act: Regulates minimum remuneration.
- Employment Equity Act: Promotes fair labour practices and equality.
- Collective Agreements: Bargaining councils set regulations for conditions of employment within their scope.

#### Unilateral Changes:

 Any changes made by the employer to employment conditions without employee consent, including remuneration, working hours, and duties, are considered unilateral changes.

#### Section 64(4):

 Employees or their trade unions can refer disputes to the CCMA or Bargaining Council, with a 48-hour window for employers to withhold the change.

#### **CCMA and Bargaining Councils:**

- . The CCMA can mediate and grant relief, including restitution or compensation.
- · Bargaining councils have the same authority when the business falls within their scope.

#### Labour Court:

 If disputes are unresolved, a referral to the Labour Court can be made for adjudication under Section 77 of the LRA, especially for unfair labour practices.

#### Picketing and Strikes:

 Unions may apply for picketing rights if unilateral changes occur, but compliance with valid picketing rules is mandatory to avoid misconduct.
