If Same Terms than a contract is created and no 2-207 issue

If Additional/Different Terms we have 2-207 problem

No.
Acceptance not expressly conditional, contract is on terms set by 207(2)

Definite and seasonable expression of acceptance is given. Is acceptance expressly conditioned on assent to additional/different terms?

No definite and seasonable expression of acceptance but maybe 207(3) K?

Either party is not a merchant? Additional terms are not included unless party separately assented

Both parties are merchants. additional terms are in contract unless:

- (a) Offer expressly limits acceptance to terms of the offer
- (b) Additional terms materially alter the contract
- (c) Object given within reasonable time

Different Terms, majority knockout and fill gaps

Yes.
Acceptance is a counteroffer

Conduct does not indicate a K exist then no contract

Conduct does indicate that a contract exists then terms set by 207(3)

Use terms that are mirror images, knock out others, add in gap fillers

If express/unequivocal assent contract is formed on counter-offer terms

No express/unequivocal assent? no 207(1) contract but see (207)(3)
