Achieving this balance is not easy It requires leaders at all levels to adjust their approach constantly They must ensure that their Soldiers and Marines are ready to be greeted with either a handshake or a hand grenade while taking on missions only infrequently practiced until recently at our combat training centers Soldiers and Marines are expected to be nation builders as well as warriors They must be prepared to help reestablish institutions and local security forces and assist in rebuilding infrastructure and basic services They must be able to facilitate establishing local governance and the rule of law The list of such tasks is long performing them involves extensive coordination and cooperation with many intergovernmental host nation and international agencies Indeed the responsibilities of leaders in a counterinsurgency campaign are daunting however the discussions in this manual alerts leaders to the challenges of such campaigns and suggest general approaches for grappling with those challenges Conducting a successful counterinsurgency campaign requires a flexible adaptive force led by agile well informed culturally astute leaders It is our hope that this manual provides the guidelines needed to succeed in operations that are exceedingly difficult and complex Our Soldiers and Marines deserve nothing less
