588G(2). By failing to prevent the company from incurring the debt, the person contravenes this section if:

- (a) the person is aware at that time that there are such grounds for so suspecting; or
- (b) a reasonable person in a like position in a company in the company's circumstances would be so aware.

The elements of the duty

- Who is liable? [s 588G(1)(a) of the Corporations Act 2001 (Cth)]
 - A person who is a director at the time when the company incurs the relevant debt.
 - Persons not formally appointed as directors but who act as de-facto or shadow directors are also subject to the duty.
- Incurs a debt [s 588G(1)(a) of the Corporations Act 2001 (Cth)]. The obligation must be an ascertainable debt involving an obligation to pay a liquidated sum instead of an obligation to pay unliquidated damages or equitable compensation for breach of fiduciary duty by the director [Hawkins v Bank of China (1992) 26 NSWLR 562]:
 - "Debt" was held to include a contingent liability such as a guarantee.
 - "Incurs" was held to include the undertaking of an engagement to pay a sum of money at a future time, even if the engagement is conditional and the amount involved is uncertain.
- When is debt incurred? [table in s 588G(1A) of the Corporations Act 2001 (Cth)]. This is
 important because s 588G(1)(b) of the Corporations Act 2001 (Cth) requires proof that the
 company is insolvent at the time the transaction took place.
- Insolvency. The test for insolvency is outlined in s 95Aof the Corporations Act 2001 (Cth):

95A(1). A person is solvent if, and only if, the person is able to pay all the person's debts, as and when they become due and payable.

95A(2). A person who is not solvent is insolvent.

- Even if company owed substantial amounts of money it must be foreseeable that this
 money will be paid in sufficient time to pay current debts. Hence the relevant test is a
 'cash flow' test not an 'assets over liabilities' test [Metropolitan Fire Systems Pty Ltd v
 Miller (1997) 23 ACSR 699].
- Rebuttable presumption of insolvency s 588E of the Corporations Act 2001 (Cth) operates to assist in proving that a company was insolvent at the relevant time:
