Ratio Analysis

Liquidity Ratios Assess the company's ability to meet short term obligations Examples include the current ratio and quick ratio

Solvency Ratios Evaluate the company's ability to meet long term obligations Examples include the debt to equity ratio and interest coverage ratio

Profitability Ratios Measure the company's ability to generate profits relative to its revenue assets or equity Examples include the gross profit margin net profit margin return on assets ROA and return on equity ROE

Market Value Ratios Evaluate the company's market value relative to its financial performance Examples include the price to earnings P/E ratio price to book P/B ratio and dividend yield

Vertical Analysis Vertical analysis involves expressing each line item on the financial statements as a percentage of a base figure typically total revenue for the income statement and total assets or liabilities for the balance sheet This helps identify trends patterns and relationships within the financial statements

Horizontal Analysis Horizontal analysis also known as trend analysis involves comparing financial data over multiple periods to identify changes trends and growth rates This analysis helps assess the company's performance and financial condition over time

Common Size Financial Statements Common size financial statements express each line item as a percentage of a base figure such as total revenue for the income statement or total assets for the balance sheet This standardization allows for easier comparison of financial data across companies industries or time periods

DuPont Analysis DuPont analysis breaks down the return on equity ROE into its component parts to identify the drivers of profitability It decomposes ROE into the product of three ratios net profit margin asset turnover and financial leverage This analysis helps identify areas for improvement in profitability and efficiency

Cash Flow Analysis Cash flow analysis involves examining the company's cash flows from operating investing and financing activities to assess its ability to generate cash invest in growth opportunities and meet financial obligations

Comparative Analysis Comparative analysis involves comparing the company's financial performance and position with its peers industry benchmarks or competitors This analysis helps identify strengths weaknesses opportunities and threats facing the company relative to its competitors
