# PRIVATE EQUITY

Investment in or acquisition of a stable firm using a combination of equity and debt, often dubbed a "Leveraged Buyout" or LBO

#### VENTURE CAPITAL

Investment of equity into a newer (or startup) company with high growth potential

#### TYPES OF COMPANIES



Stable, established companies across a wide spectrum of industries that are performing well. Early-stage companies that have very high growth potential, such as some companies in high technology, information technology, and biosechnology



#### SIZE OF INVESTMENT



Typically larger than venture capital investments but can range from \$5 million to billions of dollars depending on the target company Typically smaller than private equity and initially between \$1 million and \$10 million



#### STRUCTURE OF INVESTMENT



A combination of equity and debt

Cash or equity investment or convertible debt that turns into equity



#### OWNERSHIP PROFILE



Control investments, typically in excess of 50%

Minority investments often among a group of minority investors



#### RETURN PROFILE



More stable return profile with less volatility than venture capital Higher risk investments with a broader set of outcomes - from "home runs" to total loss of investment
