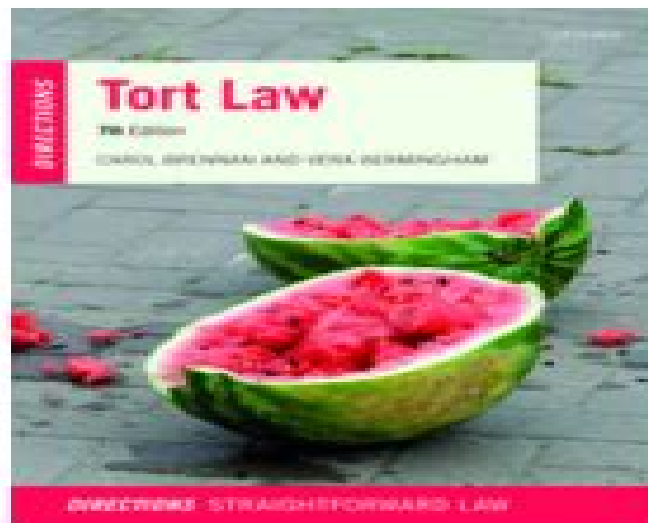

when the dignitaries RSVP you should mention we re hoping he she will honor us by saying a few words to make sure they know you wish them to speak at the ceremony you may want to
