Raised by grandparents who lived during slavery, Scott grew up learning about the horrors of that institution, and he himself experienced the injustices of Jim Crow laws. Without bitterness or anger, he chronicles almost one hundred years of life in the parish, including migrations between the two world wars, the displacement of African American farmers during the New Deal, and the shocking methods white southerners used to keep African Americans under economic domination and away from the polls. Chapter president of the National Association for the Advancement of Colored People for more than thirty years and a recipient of the A. P. Tureaud Citizens Award, Scott embodied the persistence, strength, and raw courage required of African American leaders in the rural South, particularly in the 1950s and 1960s.
